For us, this is absolutely the critical area to focus on. If you crack this, then good things will come; but we recognise the capacity constraints and changes that will have to happen around culture and commitment for this to happen. We would be happy to work with Police Scotland on this.

There is a danger that the national expertise in the form of specialist resources has removed local community policing resources and balancing these two capabilities is critical.

We would welcome more detail on what and how Police Scotland will support the changing nature of communities.

We suggest that if Police Scotland were to take a human rights approach across the piece to the work that they do this would hugely enhance the work identified in the priorities above and the model of policing by consent.

Police Scotland's direction of travel on the CAM would benefit from a better understanding of the contributory factors and the knock-on effect on partners to support delivery.
