1 How do you feel about the proposal to not include the clauses within Sections 1 to 5 of Part 1 of the current Housing for Varying Needs design guide in the updated guide?

I agree with the proposal

Please explain the reasons for your answer.:

This reply is compiled from SCSN's organisational knowledge – through an experienced staff team and a presentation on the consultation at the recent

Home Safety Scotland Forum. At the Scottish Community Safety Network we believe that the guide needed to be updated to reflect the changes in population especially with an ageing population and the likely impact this will have in terms of increase in dementia sufferers and other cognitive impairment illnesses.

Section 6 – The overall plan of the dwelling

2 How do you feel about the proposals for Section 6 of Part 1 of the current guide?

I agree with some but not all of the proposals

Please explain the reasons for your answer.:

We agree with some of the proposals however believe that another key safety proposal to prevent slips, trips and falls in the homes has been missed with

a specific requirement for BS5395-1 for safer stairs to be included within the proposals. RoSPA research indicates that installing stairways to meet this

specific standard reduces falls by up to 60%. By installing these stairways there is likely t be a cost saving with a reduction in hospital treatment compared

with the cost of installing these stairways into new build properties.

Section 7 – Access to dwellings and provision for vehicles

3 How do you feel about the proposal to update clauses 7.5.1 and 7.5.5 of the current guide to require that:

I agree with all of the proposal

Please explain the reasons for your answer.:

Scotland's new homes need to be accessible for all to use. A ramped entrance will provide for this and will hopefully prevent falls for those who require

mobility aids.

Another element to consider is the rise in the number of electric vehicles currently on the road and to ensure that the driveway has an accessible charging port suitable for those who require the use of wheelchairs.

4 How do you feel about the proposal to update clauses 7.6.3 and 7.6.5 of the current guide to require that the entrance platform should have dimensions of at least 1500mm by 1800mm in cases where a communal entrance door opens outwards?

I agree with the proposal

We support this approach to increase the width and dimensions of the communal door. This would be to enable people with mobility aids to enter the

communal close. Horizon scanning, there may be some questions with regards to ownership of the communal door if the property is of mixed tenure.

The proposal is supported as it provides the dimension for mobility aids to be used.

Please explain the reasons for your answer.:

Yes we agree with the proposals for an automatic door opening for the communal door. We would propose that this is the first option for communal

doors with manual doors the secondary option. We also support the proposal for an adjustable timed opening for the door. Clarity would be needed for

the homeowner on who has responsibility for the setting of the time.

8 How do you feel about the proposal to require that internal doors within communal access areas should have a minimum clear opening width of 850mm between the door face on one side and the door stop, or second door, on the other?

I agree with the proposal

Please explain the reasons for your answer.:

As per previous answers the door should be open as wide as possible to allow for wheelchairs or people assisting mobility aid users sufficient space to

move safely around.

I agree with all of the proposal

Please explain the reasons for your answer.:

We are pleased that the proposals include considerations for dementia sufferers especially with the colour coding. We would ask that any additional

proposals for adaptable homes should be evidenced led especially with the research at Stirling University.

consultation paper?

I agree with some but not all of the proposals

Please explain the reasons for your answer.:

We agree with the proposals however it is our belief that the BS5395-1 safer stairs should also be included. As previously reported, RoSPA highlighted

that ensuring the stairs meet this requirement it will reduce falls by up to 60%. As the proposals are specifically designed for inclusive living, we believe

that the improvement in safety designs for stairs will allow people to reside in their own homes.

Section 9 – Entrance doors to individual housing or flats

I agree with all of the proposal

Please explain the reasons for your answer.:

We support this proposal as it now required new build properties to meet this clause and that it will be considered the standard dimensions. With this

being the standard it would also be accepted as the "minimum" dimension.

may be personalised/ made distinctive from other neighbouring entrance doors, subject to any local planning restrictions that may be in place?

We agree with this proposal as the stigmatization work undertaken by the Inclusive Living Alliance highlights the occupants could be stigmatized because

of properties that have been adapted. By conferring with the resident, it should reduce the risk of stigmatisation.

We agree with the proposals on the provision that a standard test has been completed and that this is sufficient space for a wheelchair user to move

Please explain the reasons for your answer.:

We fully support the proposals to increase the turning circle for a wheelchair user to provide them with dignity in their own homes. We do question however the validity of overall costs for the increase in area for the house.

With the current housing crisis we do not believe that the 2 metre mat at the front of the property should be restricted to the houses of wheelchair users

alone. We are aware of the delay of building adaptations or the limited housing stock for suitable new build properties for wheelchair users. We believe

that a mat installed to allow for wheelchair access inside the property will assist with the dual usage of a property for those using mobility aids and those

who do not need them at the time of purchasing the property.

seen as a higher weight contrasted with the rest of the responses.
