## Water Safety Scotland to host its first Water Safety Open Day

Water Safety Scotland is delighted to be hosting it's first-ever Water Safety Open Day at Helix Park, Falkirk on Monday 25 July 1100-1500 to coincide with the second annual World Drowning Prevention Day.

This event is being funded jointly by Royal Society for the Prevention of Accidents (RoSPA), Scottish Fire and Rescue Service, Royal National Lifeboat Institution (RNLI) and Scottish Water. The focus of the day is of course drowning prevention and encouraging safety around water, but our intention is to do this in a fun way with plenty of learning opportunities provided.

There will be approximately 20 stand holders which will include, among others: Police Scotland, Scottish Fire and Rescue Service, Scottish Ambulance Service, Young Scot, Water Safety Scotland, Scottish Water, Royal National Lifeboat Institution, Scottish Canals, Scottish Community Safety Network.

### Scottish Partnership Against Rural Crime (SPARC) Strategy (2022-2025) launched

SCSN was delighted to attend the launch of the new Scottish Partnership Against Rural Crime (SPARC) Strategy for 2022-2025 on 24th June at the Royal Highland Show. SCSN is one of a number of community safety organisations who are members of the SPARC partnership.

The new three year strategy will seek to tackle rural crime and 'develop resilient rural communities'.

The aim of the SPARC is "protecting rural communities with a focus on prevention, intelligence, enforcement and reassurances".

The SPARC's four objectives:

- Develop resilient rural communities through effective partnerships, utilising holistic innovative and special techniques;
- Listen, be visible and understand local and national concerns relating to rural crime;
- Harness the contribution, expertise and knowledge of individuals, communities and



relevant partner organisations in public, private and the third sector to reduce vulnerabilities;

- Promote and improve rural community cohesion where people feel safer regardless of location.

John McKenzie, chief superintendent of Police Scotland and chair of the SPARC, said the group "recognises the need to tackle rural crime in all its forms, plus target any criminality, including those 'Serious Organised Crime Groups' who want to make money at the expense of hard working, law-abiding people, thus threatening the very fabric of rural communities".

The [Breaking barriers to reduce inequalities hub](#) is a new resource specifically developed to help those in public service roles actively reduce inequalities in the services they provide. The hub offers guidance, practical examples, methods and approaches that work to reduce inequalities through various tools, frameworks and activities. It promotes values and behaviours that underpin human rights and contribute to reducing inequalities in practice.

The hub is primarily aimed at essential and emergency public services across all sectors, including health, social care, education, housing, police, fire and rescue services. It is also useful for everyone who works in public service, to support action to reduce inequalities and improve population life outcomes.

Designed as a flexible resource, learners can dip in and out of sections based on their learning needs, source information about how they can improve their day-to-day working practice and take action.

## Three-quarters of Police Scotland incidents not crimes, report says



### A lack of support for people suffering from mental health crises is having a major impact on Police Scotland, according to a new report.

HM Chief Inspector Constabulary in Scotland found 73% of incidents attended by police last year did not lead to any crime being recorded.

The inspector, Craig Naylor, linked it to more people suffering mental ill-health being referred to the police. Officers were spending more time taking them to A&E, he said.

Mr Naylor said it was an example of where police were filling in the gaps while public sector organisations were still under strain as a result of the pandemic.

"We heard from many police officers about individuals suffering mental ill-health being referred to response policing, either because individuals were receiving community-based treatment but had no assistance out of normal office hours or, in some cases, there was no appropriate support available at that time," he said.

The [inspector's annual report for 2021/22](#) has been published as Police Scotland officers prepare to "withdraw goodwill" over a pay dispute.

## Consultation: Police Complaints & Misconduct

Plans for future legislation are part of the Scottish Government's response to an independent review into the handling of complaints against the police.

The Scottish Government has launched a 12-week consultation on a new Bill which delivers on a Programme for Government commitment made in September last year.

The consultation follows the recommendations

of an independent review of police complaints handling, investigations and misconduct in Scotland by Dame Elish Angiolini.

A total of 34 recommendations have been implemented since her report was published in 2020, but others require legislative change.

The consultation on a proposed Police Complaints, Investigations and Misconduct Bill will seek views on a number of key reforms.

## Evidence Review into Public Experience and Confidence of Body Worn Video in a Policing Context



SIPR was delighted to support Police Scotland in the award of a grant which set out to explore the use of Body-Worn Video (BWV) cameras in a policing context, with specific reference to police citizen interactions and scrutiny mechanisms.

The research was undertaken by with a view to providing advice and guidance to Police

Scotland for the potential widespread future roll-out of BWV in Scotland.

The rationale for the use of BWV in policing is well established and is afforded a good level of public support, however, there is opportunity to learn from 'best practice' in the UK and beyond. As such the authors have provided a number of recommendations which would support effective and efficient role-out of BWV.

## Research Funding: Developing Effective Policing Systems, Capability and Resilience

The Scottish Institute for Policing Research (SIPR) is providing research funding to researchers based at [SIPR member universities](#). These innovative and original research projects will contribute to [SIPR Strategic Research Priorities](#) overall but will focus on the challenges and emerging issues related to our third strategic aim “**Policing systems, capability, and resilience**”.

There are increasing and changing demands on policing with evidence of increasing complexity for response, investigations and ensuring best practice to support the public and communities. The level and pace of change in policing

presents both opportunities and challenges including:

- Ensuring colleagues have the right skills, capability and capacity;
  - Supporting new and innovative approaches to operational policing;
  - Making the best use of data, analysis, evidence and insights;
  - Continuing to focus on equality, diversity, inclusion and human rights in policing practice and within the organisation; and
- Colleague wellbeing, safety and protection.

## Latest Monthly Safer Communities and Justice Brief published

The latest Justice Analytical Services monthly [Safer Communities and Justice Brief for June 2022](#) is now available on the Scottish Government website.

Whilst crime is at it's lowest level since 1974, and down 14% since 2013, among some of the notable statistics from the latest brief are:

- **Violent crime increased in the most recent year.** Non-sexual crimes of violence recorded by the police increased by 12%, to 69,286 in 2021-22.
- **Recorded sexual crimes increased in the**

**most recent year.** Sexual crimes recorded by the police increased by 15%, to 15,049 in 2021-22. These crimes are now at the highest level seen since 1971.

- **Decrease in crime clear up rate.** The clear up rate for all recorded crimes was 54.0% in 2021-22, down from 59.3% in 2020-21 and similar to 54.9% in 2019-20.
- Whilst there was a marginal decrease in recorded hate crime, sexual orientation, disability and transgender identity aggravated hate crime charges saw an increase.
- **Small increase in firearm offences.**

Aside from this, there will be demonstrations taking place in the nearby lagoon. Those coming to the event will see simulated water rescues by Police Scotland and Scottish Fire and Rescue Service, a rescue dog performing a simulated rescue and emergency services demonstrating throwbag water rescues.

By the side of the lagoon, there will be a CPR demonstration taking place by Scottish Ambulance Service and St Andrew's First Aid will be doing a basic first aid demonstration.

Central FM - the biggest independent radio station in the area - will be broadcasting live for the duration of the event. They will be advertising the event and encouraging listeners to come down on the day, and will be

interviewing key stakeholders present at the event on air. The Minister for Community Safety, Ash Regan MSP, will also be in attendance.

There will be two competitions running on the day related to learning the Water Safety Code – one is a fun letter hunt where folks have to spot the letters hidden around the stands and put them together to reveal part of the Water Safety Code. The prizes on offer are Decathlon vouchers and a FitBit Versa and entry to the competitions is via QR code.

Last year in Scotland saw a number of high profile water safety incidents and deaths, with several drownings in the space of one awful week last July - including [several members of a family](#) in Loch Lomond.

Every year people drown both at home and on holiday because they don't take simple precautions, so reaching people with water safety messages is vital.

## Water Safety Scotland urges public to be safe around water

Water Safety Scotland (WSS) is urging the public to stay safe around Scotland's waterways during the current heatwave.

As temperatures continue to stay high, WSS is calling on people to follow the Water Safety Code. While it can be tempting to enter the water in warmer weather, sudden immersion can lead to Cold Water Shock (CWS). CWS can affect even the strongest swimmers as it overwhelms the ability to breathe and to swim, which can lead to drowning.

With more hot weather on the way, it is important to learn how to keep safe around water, follow local safety guidance and to avoid alcohol on and near waterways.

Last year, 58 people sadly lost their lives to accidental drowning in Scotland; the majority of which were in inland open waterways such as rivers, canals and lochs (67 per cent).

To help reduce drowning fatalities, Water Safety Scotland is highlighting the Water Safety Code and the new UK campaign, Respect the

Water (which is due for release on July 25, 2022).

The Water Safety Code is an easy-to-remember three-step code, and provides some life saving advice that aims to help keep you and those you are with safe when near open water:

- Stop and Think, Spot the Dangers
- Stay Together, Stay Safe
- In an Emergency, Call 999.

### World Drowning Prevention Day - 25 July



The United Nations General Assembly adopted a historic resolution on global drowning prevention on 28 April 2021.

The resolution recognises the scale and impact of drowning prevention globally, and calls for coordinated multisectoral action to prevent drowning, a leading cause of injury-related death and disability worldwide.

A key element of the resolution is that it establishes a new UN-recognised World Drowning Prevention Day, all stakeholders, including governments, nongovernmental organisations and their partners, are invited and encouraged to contribute to, and engage in, this global day of activity.

- Provide person-centred support for young people, parents and families impacted by Adverse Childhood Experiences and trauma
- Support young people to improve their health, mental health and wellbeing
- Support people, families and communities most affected by crime

## Climate 2050x Fund Open!

2050 Climate Group's Leaders Network run a funding initiative called 2050x. Through our 2050x Fund 2050 Climate Group offers financial support for projects aiming to tackle an aspect of climate change. This unique opportunity is open to all 18 - 35 year olds, based in Scotland, who have a project idea that requires some extra resources and support.

Successful applicants will receive a financial contribution, as well as support from the 2050 Climate Group, which can provide climate change expertise from a broad range of sectors and access to a

wide network of contacts. This financial support could be anywhere from £50 to £1,000 depending on the funding needed, and each application will be reviewed on a case by case basis.

2050x projects should be aligned with the 2050 Climate Group's charitable purpose, that is the education, engagement and empowerment of the next generation of leaders to take action on climate change and the advancement of education on climate change and leadership skills. Beyond this condition, projects may be wide ranging and we will consider all applications.

## ERCS welcomes exemption of court fees for some Aarhus cases

The Scottish Government has published its response to their consultation on court fees, along with [secondary legislation](#) which will implement agreed changes, effective from 1 July.

The Environmental Rights Centre Scotland (ERCS) has welcomed the decision to exempt Aarhus cases heard in the Court of Session from court fees. This is a key demand of their [advocacy manifesto](#), and described as a positive step towards reducing barriers to accessing justice on the environment. ERCS say it is disappointing that Aarhus cases in other courts (e.g. Sheriff Courts) are unaffected by this decision – with litigants still liable to pay fees.

The ERCS says removing court fees is an important step to reducing legal expenses. However, much [more needs to be done](#) to make it affordable for all of us to uphold environmental laws in court and enforce our human right to a healthy environment.

Scotland remains in breach of Article 9 of the Aarhus Convention, that access to justice must not be 'prohibitively expensive'.

It builds on the widely used [Place Standard Tool](#) (PST), which provides a simple framework to structure conversation about place, based around 14 themes.

The Place Standard with a climate lens will help people to understand how climate change might play out in a local area and support them to design their future place in mind.


### New: Home Safety Map Published

### New call for UK public to stop using heated hairbrush and dryer model



The Office for Product Safety and Standards (OPSS) has issued a further warning to the public to stop using a heated hairbrush and dryer which can catch fire during normal use.

The product, originally branded 'One Step model SM-5250', was initially subject to a Safety Gate alert notified by the UK in 2020. However, OPSS has since identified it is again being sold through online marketplaces. ## Electrical Safety First Plug Checker



Sub-standard and counterfeit electrical plugs can be deadly!

The Plug Checker has been developed to allow you to quickly check and ensure the plugs on your electrical appliances meet the required standards.

It enables the user to perform 3 simple tests, in which should the plug fail on any of these checks, the appliance should not be used as it could put you at risk. Plug Checkers are available to purchase for just £1 each.
