- Trading Standards Scotland's strategic vision is to reduce consumer detriment by undertaking cross border and national consumer casework and coordinating activity in relation to national enforcement priorities in Scotland.
- TSS is also responsible for establishing national enforcement priorities and coordination activity in relation to them.
- We do this via three strands:
- Enforcement.
- Intelligence
- Prevention



Background

- Often inaccurately known as legal highs;
- Dangerous products sold to consumers with the object of mimicking illegal drugs;
- Openly sold predominantly, although not exclusively, in high street establishments known as 'head shops' as well as through online retailers;
- Labelled as 'not for human consumption' and marked as research chemicals, room deodoriser etc;
- Full knowledge that the products are being consumed for their psychoactive effect and have no utility as per their false descriptions.



Harms

- 203 deaths between 2009 and 2013 where NPS was present in the bloodstream.
- Wide and concerning array of harms including kidney failure, heart and lung problems, hyperthermia, aggressive and unpredictable behaviour, memory loss and psychosis.
- Addictive and requiring intensive rehabilitation programmes.
- Longer term impacts not fully known.

Psychoactive Substances Bill

The Bill will:

Make it an offence to produce, supply, offer to supply, possess with intent to supply, import or export psychoactive substances; that is, any substance intended for human consumption that is capable of producing a psychoactive effect.

The maximum sentence will be 7 years imprisonment.



NPS Strategic Working Group

- Scottish Government Expert Review Group
- Established to provide advice to Ministers on the powers available to tackle the sale and supply of NPS
- Acknowledged powers that Trading Standards have that could be considered, in particular the General Product Safety Regulations (2005)
- Recommended that a toolkit providing operational guidance to assist frontline Trading Standards staff in tackling NPS be produced to ensure consistency of enforcement action.



Guidance for Trading Standards

- Covers applicable laws, partnership working and focusses primarily on GPSRs.
- Launched on 15 September 2015.



Intelligence

- Beginning to establish a clearer intelligence picture.
- However key intelligence gaps remain.
- Seeking to overcome this by carrying out a joint project between the national team and Trading Standards services across Scotland.


